

## Health and Safety Statement of Intent

Responsibility to act as Workforce Representative is circulated within the team, to encourage ownership of health & safety matters. Reference should be made to either the Workforce Representative or the undersigned Director in the event of any difficulty arising in the implementation of this policy.

This health and safety statement of intent shall be reviewed annually, and the associated documentation, will be reviewed at a frequency commensurate with the risk controlled.
